**JOB DUTIES:** The Women's Health Nurse Practitioner (WHNP) will provide comprehensive, patient-centered healthcare to women across the lifespan, with a focus on reproductive, gynecologic, obstetrics and preventive health. The WHNP collaborates with physicians, Certified Nurse Midwives, nurse practitioners and other healthcare professionals to deliver high-quality clinical care, education, and counseling while promoting wellness and disease prevention. WHNP will provide a wide variety of women's health services including but not limited to:

- Provide Gynecologic and reproductive healthcare, including routine exams, screenings, and preventive care
- Provide Obstetric care to low-risk OB patients - including prenatal, postpartum care
- Diagnose and manage acute and chronic conditions related to women's health
- Perform and interpret diagnostic tests (Pap smears, STI testing, pregnancy testing, etc.)
